

# STATEMENT

### Introduction

**DNV Business Assurance USA, Inc. (DNV)** has been commissioned by the management of AZIENDA LAVORAZIONI METALLURGICHE ED AFFINI GNUTTI SPA (A.L.M.A.G. SPA) to carry out an independent verification of its greenhouse gas (GHG) emissions relevant to the 2023 calendar year.

A.L.M.A.G. SPA has sole responsibility for preparation of the data and external report. DNV, in performing our assurance work, is responsible to the management of A.L.M.A.G. SPA. Our assurance statement, however, represents our independent opinion and is intended to inform all stakeholders including A.L.M.A.G. SPA.

## **Verification Objective**

The verification objective is to assess conformance with applicable verification criteria, including the principles and requirements of relevant standards or GHG programmes, within the scope of the verification related to the organization's 2023 GHG inventories, as described in the GHG emission report, "Relazione Carbon Footprint di Organizzazione ALMAG SpA", issued on 27 March 2024, and the organization's GHG related controls.

## **Verification Scope**

2023 GHG emissions inventory which include: Direct GHG emissions (Cat.1), Indirect energy GHG emissions (Cat.2), Indirect GHG emissions from transportation (Cat.3), Indirect GHG emissions from products and services used by the organization (Cat.4).

#### **Verification Level of Assurance**

The verification was conducted by DNV to a limited level of assurance with the eventual modifications reported in the below Verification opinion.

## **Materiality Level**

Errors / omissions which represent, single or aggregated, the 5% of total emissions are considered material.

#### **Verification Criteria**

• ISO 14064-1:2018: Greenhouse gases - Part 1: Specification with guidance at the organization level for quantification and reporting of greenhouse gas emissions and removals

#### **Verification Protocols**

• ISO 14064-3:2019 Greenhouse gases - Part 3: Specification with guidance for the verification and validation of greenhouse gas statements
